Background:

Land Core Group (LCG) is a local NGO promoting accountable, just, and equitable land governance in Myanmar. We work with government and civil society to reform policies, laws and procedures that impact the rights of women and men smallholder farmers and indigenous communities to access, use and control land and natural resources, and improve implementation of policies, laws and procedures that help to protect those rights.

The Land Core Group was established as a working group within the Food Security Working Group. In 2015, the working group decided to establish Land Core Group as an independent organization.

Today, LCG is registered as an NGO. It does not have a membership and does not represent any other civil society organisations. However, because of its name, people often assume that LCG is a network. There is also confusion over the relationship between LCG and the earlier working group.

To avoid confusion, and to strengthen its relations with other organisations, LCG has decided to change its name and logo. However, after more than one year, we have still not been able to come up with a suitable name.

For this reason, LCG is currently recruiting a consultant to identify potential new names.

Responsibilities

The Consultant will be responsible for identifying suitable new names (with both English and Myanmar versions of each name) from which LCG can choose. He/she should:

1. Familiarize him/herself with LCG's efforts to identify a new name to date and vision for the future of LCG.
2. Identify potential types of names and strategies for identifying names, and come up with an initial set of potential names
3. Following feedback from LCG, come up with a second set of potential names

The time period of the consultancy is flexible.
